

EXHIBIT A
Rules and Regulations for Participating Team Trails

1. Prior to November 1, of each year during the Term, each Participating Team Trail must hold a minimum of 4 tournament events, with two-people per team (each, an "Eligible Event").
2. Each Participating Team Trail shall have an established and pre-determined method for determining the most successful teams participating across multiple Eligible Events, such as a "team of the year" ranking or "championship winner," with the most successful team(s) becoming eligible to fish the Bassmaster Team Championship. This method is to be submitted to B.A.S.S. by 04/01/2023.
3. 2023 full-time Bassmaster Elite Series or 2023 Major League Fishing, Bass Pro Tour or 2023 National Professional Fishing League and its subsidiary touring pros (collectively, "Pro Angler") are not eligible to compete in the B.A.S.S. Team Championship. Touring Pro Anglers as defined above are allowed to participate in Team Trails but do not count towards membership totals.
4. Each Participating Team Trail shall abide by these Rules and Regulations and conduct each Eligible Event in a manner that promotes responsible fish care and sportsmanship and, in the sole discretion of B.A.S.S., reflects favorably on the reputation of B.A.S.S., its members, officers, sponsors, or representatives. Failure to do so may result in a revocation of the Team's eligibility as a Participating Team Trail and disqualification of its members from the Bassmaster Team Championship.
5. Each Participating Team Trail shall be entitled to use the Bassmaster Team Championship logo and other B.A.S.S. Licensed Marks provided by B.A.S.S. in all marketing materials and in compliance with the terms of the Agreement. Each Participating Team Trail shall display a B.A.S.S. provided logood banner at all Eligible Events. In the event there is a conflict with any use of the Bassmaster Team Championship logo, the B.A.S.S. Licensed Marks, or banner then Team Trail may obtain separate, written approval from B.A.S.S. for alternative materials to use in Team Trail's marketing materials and for display at Eligible Events.
6. Each Participating Team Trail shall be entitled to place Bassmaster Team Championship widget/banner that is provided by B.A.S.S. on the Participating Team Trail's website home page. Such widget/banner will link to www.Bassmaster.com/Team.
7. Each Participating Team Trail is requested to provide photographs and tournament standings to B.A.S.S. for placement on www.Bassmaster.com following each event. Each Participating Team Trail shall use its best efforts to also provide a video and/or story as content and placement on www.Bassmaster.com.
8. The Participating Team Trail shall register and ensure all Team Trail participants have an active B.A.S.S. Nation membership, for each individual that competes in at least (1) tournament during the 2023 Team Trail, to B.A.S.S. subject to and in accordance with the Agreement. The Participating Team Trail must provide the following information for each individual participant: **name, mailing address, EMAIL, mobile phone number and phone number** and an agreement to the terms required by Section 7(b) of the Agreement. Team participants will receive a B.A.S.S. Team membership including B.A.S.S. Times magazine.
9. Roster for a minimum of 25 teams (50 individuals) must be received by September 1, 2023. B.A.S.S. reserves the right to extend this deadline, if requested in writing by August 1, 2023. Rosters must be completed in full through the google form provided by B.A.S.S.
10. Team Trail Agreements must be signed and received by 04/01/2023.
